Women Grievance Redressal Committee

The Women Grievance and Redressal Committee received a complaint during the academic year 2019-2020, with related to the cleaning of toilets. The complaints highlighted unhygienic conditions, lack of sanitation, and inadequate waste disposal in these areas. The committee took prompt action, holding meetings with facility management and deploying additional cleaning staff. Regular inspections were conducted to ensure that the issues were addressed.

The committee recommends regular maintenance and cleaning of toilets, an increase in cleaning staff and resources, awareness campaigns to educate students and staff about hygiene and cleanliness, and an expansion of the committee's scope to address other women's issues and grievances. The committee did not receive any complaints about grievances related to harassment, discrimination, and other issues.
