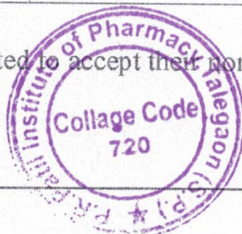

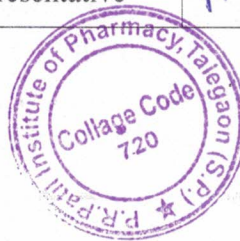

Women Grievance Redressal Committee
